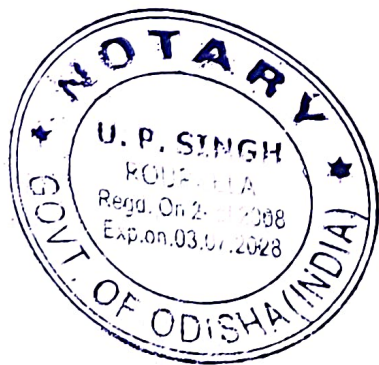
1. That as the Secretary, I have been authorized on behalf of the Vikash Ind Global School to sign any documents in connection with above Institutions in any documents.

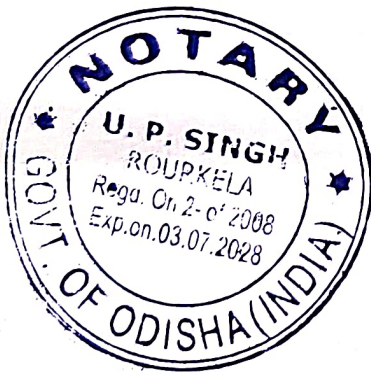


